
Client declarations

Each time you lodge an approved form on behalf of your clients, the law requires you to have first received a signed declaration in writing from your client. This includes all approved forms such as activity statements and tax returns.

The client declaration must state that:

- they have authorised you to lodge the document and
- the information is true and correct.



Your client is required to retain the declaration (or a copy) for up to five years, depending on their circumstances. We recommend you also keep a copy of the declaration for your own records. This declaration can be stored electronically regardless of whether it was received by email or in paper form. Paper declarations can be scanned and stored electronically.



Applying for AUSkey, GST, PAYG and business name

As part of the Australian business number (ABN) application you can apply for other business registrations. Applying for other registrations at the same time as your ABN will save you time as some information will be pre-filled for you.

Depending on the <u>status of your ABN application</u> and your entity type you will be presented with different registration options.

Apply for a TFN for business

Depending on the <u>status of your ABN application</u> and your entity type you will be presented with different registration options.

If your application was refused you will not be able to continue to apply for other business registrations.

7. Process Payrun

- a. Calculate gross amounts to be paid
- b. Apply taxes etc
- c. Verification and Authorisation to make payments
- d. Payslips to be provided to the Employee
- Payment instructions for the employee's net pay (preferably through payment gateway in the software) and make payment
